From Rt. 95 and South: Rt. 95 to Rt. 495 south, merge onto 25 south to Cape Cod. Cross the Bourne Bridge, onto 28 south to Falmouth, take route 151 exit toward Mashpee. Continue 2.7 miles to Crane WMA on left.

From Boston and North: Rt 93 south to Rt 3 south to Cape Cod. Cross the Sagamore Bridge. Take 1st exit to Rt 6A toward Falmouth. 6A to 28 south to Falmouth, take route 151 exit toward Mashpee. Continue 2.7 miles to Crane WMA on left

From Providence RI: Rt 195 to Rt. 495 south, merge onto 25 south to Cape Cod. Cross the Bourne Bridge, onto 28 south to Falmouth, take route 151 exit toward Mashpee. Continue 2.7 miles to Crane WMA on left.
